EMOTIONAL APPEAL AND MOTIVATION (PATHOS)

WHEN COMPARED TO OTHER NOTABLE MILITARY SPEECHES, SUCH AS WINSTON CHURCHILL’S ADDRESSES DURING WORLD WAR II, ELIZABETH’S SPEECH SHARES SEVERAL FEATURES: IT AIMS TO UNITE, REASSURE, AND INSPIRE IN THE FACE OF EXISTENTIAL THREAT. - **ELIZABETH’S SPEECH** BALANCES REALISM WITH SYMBOLIC ASSURANCE AND EMOTIONAL WARMTH.
- BOTH UTILIZE STRONG RHETORICAL DEVICES, BUT ELIZABETH’S ADDRESS IS PARTICULARLY NOTABLE FOR ITS GENDERED MESSAGING AND CEREMONIAL TONE.
