CANDIDATES SHOULD COMPLEMENT THEIR READING WITH ACTIVE LEARNING METHODS SUCH AS NOTE-TAKING, FLASHCARDS, AND GROUP DISCUSSIONS. REGULAR SELF-ASSESSMENT USING THE BOOK'S PRACTICE QUESTIONS CAN HELP IDENTIFY KNOWLEDGE GAPS AND REINFORCE RETENTION.

ADDITIONALLY, PAIRING A PREP BOOK WITH ONLINE PRACTICE TESTS CAN SIMULATE EXAM CONDITIONS, REDUCING TEST ANXIETY AND IMPROVING TIME MANAGEMENT SKILLS.
